# WHAT YOU NEED

To obtain a D7 Visa, you're required to meet certain criteria before becoming eligible. We recommend taking out the below services, in order to qualify.

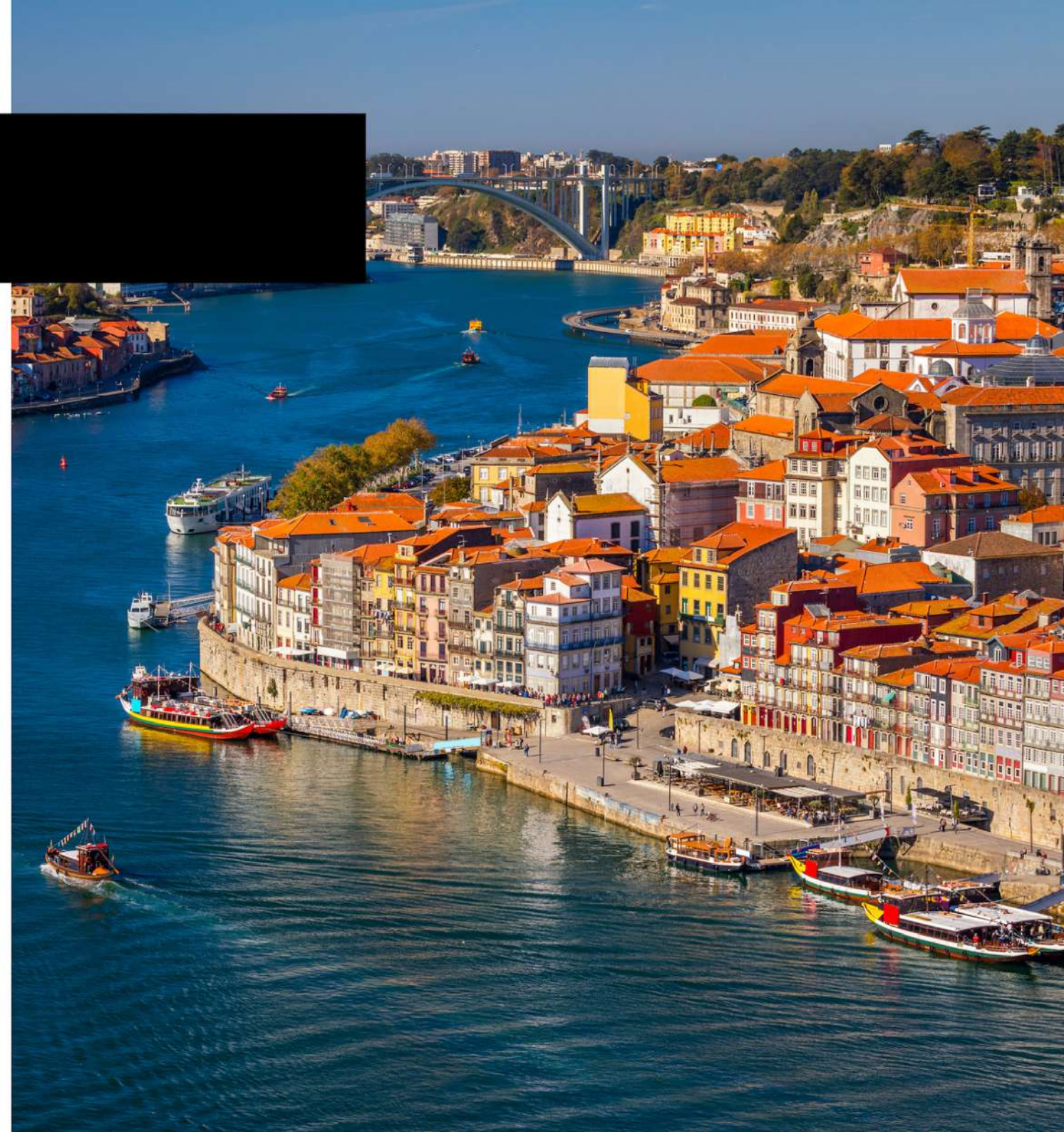

# DOCUMENTS WE NEED

1. Passport or additional travel document valid for 3 months after the duration of the stay;
2. Two passport photos, up-to-date and with enough quality to identify the applicant;
3. Valid travel insurance, allowing medical coverage, including medical emergencies and repatriation;
4. Proof of being in a regular situation when from a different nationality than that of the country where the visa is being applied for;
5. Request for criminal record inquiry by the Immigration and Border Services (SEF)

6. Criminal record certificate from the country of origin or the country where the applicant is residing for over a year (children under the age of 16 are exempt from producing a criminal record);
7. Proof of means of subsistence as stipulated by law (Work contract)
8. Proof of bank account in Portugal
9. Proof of housing
10. Place you desire to move. With all clients we can help to find a property through our real estate agents. The property will have a registered contract with the tax authority.





# WHO IS ELIGIBLE

Although the D7 visa is known as a Retirement Visa, anyone can apply for it. As long as you are above the age of 18, eligible, and meet the visa requirements, the program is open to you, no matter your country of origin.

# FAMILY MEMBERS

**When you're moving to Portugal to obtain residency it is possible for your family to obtain residency via the family reunification Visa.**

In order to obtain residency permits for the applicant's family, a similar process will have to be adhered to for them.

The focus will be demonstrating the family bond, while the applicant must provide proof that they will be able to financially sustain all the family.



# GOVERNMENT FEES
